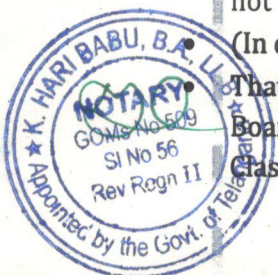
AFFIDAVIT
